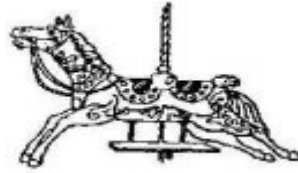

Entry Fees: Clear Round - Members £7 Non-Members £12 - Clear round rosettes

Classes 1, 2, 3 : Members £12 Non-members £18 - Rosettes to 6th place

Entries on the day **where spaces allow** £5 extra. Clear round entry at end of class for same horse/rider combination entered in class - where spaces allow – no £5 extra. First-aid is included.

CONDITIONS

1. Entry fees will only be refunded if the event is cancelled due to weather and if we are unable to reschedule.
2. The organisers, officials, helpers and landowner cannot accept any liability for accidents, injury or illness to horses, riders, spectators or any other persons or property whatsoever.
3. The organisers reserve the right to cancel or alter the course or any class if considered necessary.
4. Medical armbands, backprotectors & a skull cap or hat with safety harness according to EN1384, ASTM F1163 or PAS15 or higher must be worn by all competitors and long hair to be tied up.

5. No stopwatches and no camera on horse or rider.
6. The organisers have taken reasonable precautions to ensure the health and safety of everyone present. For these measures to be effective everyone present must themselves take reasonable precautions to avoid and prevent accidents. Instructions given by any officials must be obeyed.
7. The judges' decision is final.
8. Horse or pony must be 4 years old or over. No horse or pony may compete more than once in each class.
9. The fence judges and other officials reserve the right to withdraw any horse or pony that, in their opinion, is not fit to compete. In the event of a fall if an official feels that the horse/pony or rider is unfit to continue they will ask the competitor to leave the course
10. This Hunter Trial will be run under **Riding Club Hunter Trial Rules 2018**. Please also refer to the course map.
11. Dogs must be kept on a short lead at all times.
12. Acceptance of these conditions as to liability shall be a condition of entry or participation in this competition.
